Francine Alfandary

I am delighted to submit my candidacy for the Sephardic Brotherhood Board. My parents, Renee Passy and Robert Alfandary, had grown up in Paris and Brussels. Their parents (my grandparents) were Sephardic Jews from Constantinople. My parents met and married in Paris in the 1950s. They made their life in California. They eventually brought my four grandparents to live nearby.

I attended law school at Harvard and settled in New York after graduation. I met my husband, Laurent Nahon, at synagogue. Laurent is also a French-speaking Sephardic Jew. His parents grew up in Oran, Algeria. Together, we raised our amazing twin sons, Louis and Raphael. The boys are rising juniors at the University of Chicago. They are proud of their Sephardic heritage. We are French, Spanish and US citizens.

I am a partner at Pearl Cohen Zedek Latzer Baratz LLP, a law firm with offices in Israel, the US and the UK. I am also on the faculty of Fordham Law School. I am active in the NYC running community, having averaged one marathon a year for over 30 years. I would be proud to further the work of the Sephardic Brotherhood.

Sarah Aroeste

Inspired by her family's roots in N. Macedonia and Greece, Sarah Aroeste is determined to bring Sephardic culture to new generations. Since 2001, Aroeste has toured the globe presenting traditional and original Ladino songs with her unique blend of Balkan sounds, pop, and jazz. She has recorded eight albums, including the all-original Ladino children's album, "Ora de Despertar," the boundary pushing "Gracia," a feminist musical homage to Sephardic heroine Doña Gracia Nasi, and the award-winning "Monastir," an international musical tribute to a once thriving Balkan Jewish community. In 2014 she won the Sephardic prize at the International Jewish Music Festival in Amsterdam, and in 2015 she represented the USA in the International Sephardic Music Festival in Cordoba, Spain. Sarah is currently co-directing with chef Susan Barocas her newest initiative, Savor: A Sephardic Music & Food Experience, which unites Sephardic song and cuisine in multi-sensory platforms. In addition to composing songs, Sarah has published numerous articles and essays about Sephardic cultural preservation and writes Sephardic themed books for children, including "Mazal Bueno" (Kar-Ben 2023) and most recently, "Uno, Dos, Tres: A Sephardic Counting Book" (PJ Publishing 2025).
